

Regional Economic Trends

for St. Joseph County









DECEMBER 2021

ST. JOSEPH COUNTY

The Trend: St. Joseph County gained 274 jobs from Q1 to Q2. From August to September, the unemployment rate, labor force participation rate, and employment-to-population ratio all fell. This is likely a sign that unemployed individuals are leaving the labor force. Job postings were lower in September than in August, with retail manager as the most in-demand job.

COUNTY UPDATE

- The labor force participation rate was 58.2% in September. This is a 2.1 percentage point decrease from the previous month.
- The employment-to-population ratio was 55.9% in September. This is a decrease of 1.4 percentage points from August.
- The unemployment rate was 4.0% in September. This is a 0.9 percentage point decrease from the previous month.
- The total labor force saw a decrease of 981 people from August to September. The decrease in unemployed people was 319, and the decrease in employed people was 662.
- Total employment increased by 1.6% from Q1 to Q2.
- There were 381 job postings in September 2021, a decrease of 12.6% from August.

The labor force participation rate, which measures the economy's active workforce, was 58.2% in St. Joseph County in September. This was lower than the rate for west Michigan by 3.1 percentage points, and lower than that of the state of Michigan by 1.1 percentage points.

The employment-to-population ratio, which measures the proportion of the population that is employed, was 55.9% for St. Joseph County in September. This was 5.4 percentage points below the ratio for west Michigan and 3.4 percentage points lower than that of the state of Michigan.


State of Michigan

The unemployment rate, which measures the percentage of the workforce that is looking for work, was 4.0% in St. Joseph County in September. This was 0.1 percentage points lower than the rate for west Michigan and 0.2 percentage points higher than that of the state of Michigan.


From August to September, the unemployment rate in St. Joseph County decreased by 0.9 percentage points, to 4.0 percent. The unemployment rate is 2.2 percentage points lower than it was at the same time last year.

In July, there were 2.9 job seekers for every job posting in St. Joseph County.*


Total Labor Force (not seasonally adjusted)

The total labor force in St. Joseph County in September stood at 27,823, a decrease of 981 people from the August labor force of 28,804. The total labor force in St. Joseph County has shrunk by 2.9% since September 2020, when it stood at 28,653. This indicates a decrease in the available labor for firms in the area.

Labor Force by the Numbers, Q1 2021





Employment Change, Q2 2020 to Q2 2021 (not seasonally adjusted)





The most recent data shows that the greatest decrease in employment in St. Joseph County from Q2 2020 to Q2 2021 was in government, which declined by 21 jobs, or 0.9%. The greatest increase in employment from Q2 2020 to Q2 2021 in the county was in manufacturing, which grew by 639 jobs, or 9.7%.

The average weekly wage for nonfarm jobs in St. Joseph County in Q2 2021 was \$837.


Total Job Postings for September 2021


The number of job postings in St. Joseph County, which demonstrates demand for labor, decreased by 12.6% between August and September, from 436 postings to 381. The majority of postings in the county, as reported through Burning Glass Technologies, were for full-time and permanent positions.

The top occupations with job postings were for retail managers, security officers, and retail sales associates. The majority of job postings, 68.0%, required only a high school diploma or vocational training. This is an increase of 17.6 percentage points from August in the proportion of job postings requiring a high school diploma or vocational training. The proportion of jobs requiring an associate degree decreased by 3.9 percentage points from August, and the proportion of jobs requiring a bachelor's degree or higher decreased by 13.8 percentage points.
